# TOBACCO RETAILERS: NEW CONNECTICUT LAW EFFECTIVE TODAY!!!

**Effective July 1, 2022**, all retailers must check and verify the photo ID of **EVERYONE** who purchases cigarettes and/or other tobacco products.

The Connecticut Legislature passed PA 5506 Sec. 198. Section 53-344 (d) (1) in May 2022. The law states "A seller or seller's agent or employee shall request that each person intending to purchase cigarettes or a tobacco product present a driver's license or identity card to establish that such person is twenty-one years of age or older." This means you must check and verify EVERYONE'S photo ID. Even if you know the customer. Even if the customer looks older than 21.

All retailers received the postcard below in June 2022. Please post it in your store, so that customers are aware of the new law. If you would like to print a copy of the postcard, please visit the <u>Tobacco Merchant Information website</u>. Also, The Tobacco Merchant and Community Education Steering Committee has revised the <u>online prevention education program for retailers</u> to reflect the new law. Please encourage your employees to take the training as a refresher. **Remember: what you do matters.** 

Retailers MUST CHECK THE PHOTO ID of <u>EVERYONE</u> buying tobacco products, no matter their age (21, 30, or 60). Effective July 1, 2022
