Today, November 15th, we celebrate the 42nd annual [The Great American Smoke Out](#) so it is especially important for retailers to ask for and verify the [photo ID](#) of anyone who appears to be under the age of 27 years old before selling a tobacco or e-cigarette product. The Responsible Connecticut Retailer plays an important role in prevention and in the community. What you do matters.

Breaking news: The City of Hartford recently passed a local ordinance raising the age to purchase tobacco or an e-cigarette product to **21 years old**. 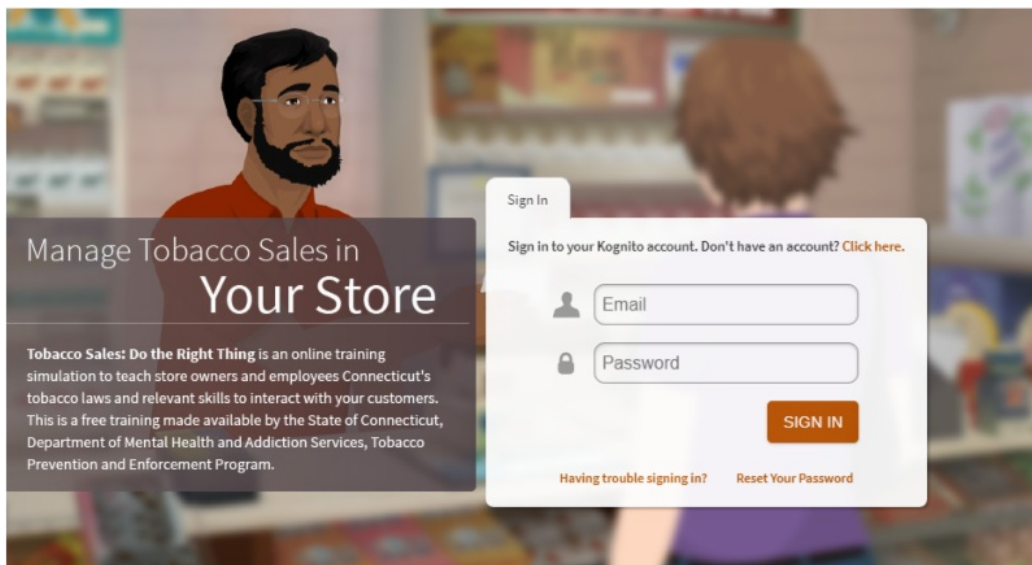
