Tobacco 21 and COVID-19 PSA - The law

Connecticut Tobacco 21 Law PSA - The

has not changed. Customers must be at least 21 years old to purchase any tobacco product, electronic cigarette, or vapor product. Retailers must check photo IDs of customers under 30 years of age. Stay safe during the pandemic. Protect yourself, your employees, and your business. Ask all customers for their photo IDs during this difficult time.

law prohibits retailers from selling any tobacco product, electronic cigarette, or vapor product to customers under 21 years of age. Retailers must ask for photo IDs from all customers under 30 years of age. Fines and penalties have increased. A summary of the law can be found here: Public Act 19-13.
