## **Workshop Descriptions**

#### Stigma and Scapegoat: The Opioid in History and Health

Mishka Terplan, MD, will review the history of opioids in health and literature from the Ancient Greek through to modern pharma. Participants will learn how the concept of stigma perpetuates inequity and begin to understand population health approaches that do less harm.

Learn about various harm reduction efforts in local Connecticut Communities. Hear from local experts about barriers to treatment and how to overcome them in your organizations.

# Supervised Injection - Lessons from the front lines of the first legally sanctioned injection site in North America

Liz will present the story of opening the first legally sanctioned safe injection site in North America; Insite. She will describe the historical context alongside the strategies required to open the site including public education, advocacy and the four pillars policy framework. She will describe the legal and court battles that took place between the Federal government of Canada and the program operator, alongside two brave program participants. Key research findings will be presented in tandem with a description of the implementation and design of the model, and its outcomes.

#### Addressing Stigma in Harm Reduction & Treatment

This keynote talk will address the role of stigma in current American approaches to substance use both generally and across the harm reduction and treatment landscape. With over 100,000 overdose deaths in the past 12 months, the United States is seeing unprecedented suffering and harm. Key aspects of this lecture will include social science theoretical frameworks such as structural violence, structural racism, and other important variables such as gender and age, that affect the lived experiences of people who use drugs and their engagement in care systems.
